At a time when foreign direct investment (FDI) flows into developed economies dropped by 40%, FDI into Canada increased 70% in 2018.

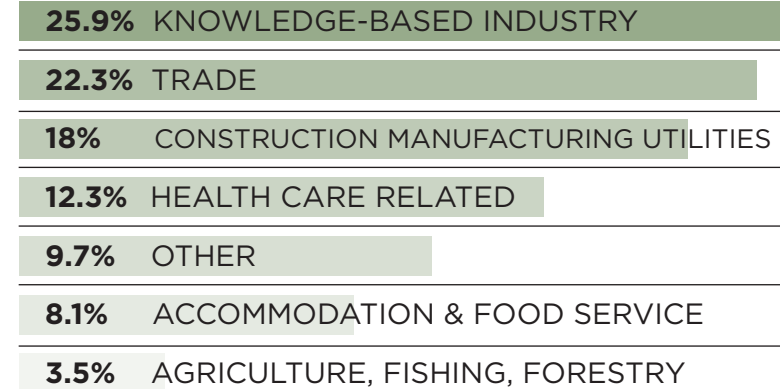

## CANADA VS. UNITED STATES

Canada's labour costs are the lowest among the G7 countries. With competitive salary levels and lower health care costs, companies based in Canada benefit from total labour costs that are 31.2% lower than equivalent costs in the United States.

Progressive reductions in both federal and provincial taxes create a significant advantage for companies operating in Canada. According to KPMG, the effective income tax rate in Canada is 17.9%, or 11.9 percentage points below that of the United States.

### AGRI-BUSINESS

Abbotsford is the Canadian hub for agri-business with annual agricultural activity amounting to \$1.8 billion within Abbotsford, which equals more than half of the Province's total GDP in this sector.

Our fertile soil, moderate climate and abundant water supply are key factors in this sector's success, supported by effective planning and policy development to ensure industry strength.

## WE'RE COMMITTED TO AGRICULTURE

The Agricultural Land Reserve (ALR) is a Provincial land use zone, designated in 1973, in which agriculture is recognized as a priority use. Within the ALR, farming is encouraged, on-farm processing is permitted and non-agricultural uses are controlled.

There are 71,865 hectares of ALR land within the Fraser Valley Regional District of which 27,413 hectares is within Abbotsford. ALR land represents approximately 75% of Abbotsford's overall land base, signaling how important this sector is to our community both now and into the future.

Building on the City's Agriculture Strategy and Official Community Plan, Abbotsford is undertaking a comprehensive planning process called AgRefresh, to review and update municipal agricultural policies, bylaws and regulations. The project aims to support and enhance the viability of agriculture in Abbotsford through improved policy guidance and updated City regulation that is clear and predictable.

## Aerospace.

British Columbia's aerospace sector is internationally renowned for its specialized products and services. The industry is supported by a network of schools that continue to produce highly-skilled workers. This talented multilingual workforce keeps our aerospace companies globally competitive and recognized. With close proximity to Boeing's final assembly lines in the Seattle area, British Columbia bridges space and culture between Asia Pacific, the Pacific Northwest and Canada's growing aerospace industry.

The sector is supported by a diverse group of technology companies able to provide nimble and responsive support and solutions to the needs of industry leaders and global supply chains.

B.C.'s aerospace sector is the third-largest in Canada. Home to more than 200 companies, it generates a total of \$2.4 billion in revenue annually and directly employs nearly 9,000 people. At the present time in Abbotsford, this sector is responsible for approximately 1,000 direct positions.

### THE OPPORTUNITY

Abbotsford is home to 215 developable, airfield-adjacent acres available for immediate occupancy. Offering competitive terms for long-term lease among an already robust aerospace cluster, this is an ideal location for companies specializing in this sector.

## Our Airfield.

### THE ABBOTSFORD INTERNATIONAL AIRPORT (YXX)

Located just 3 km from the Trans-Canada Highway and 6 km to the nearest border crossing to the United States, the Abbotsford International Airport is home to 13 related companies with airfield access in addition to an active commercial flight schedule.

Serviced by four national carriers – WestJet, Swoop, Flair Airlines, Air Canada Rouge – as well as locally owned Island Express Air offering service to Vancouver Island, the terminal has seen a steady increase in passengers through the terminal year over year. In 2019, the airport served 1,000,000 passengers, setting a new performance record.

Continuous investment and maintaining a keen focus to support the aerospace sector and its evolving needs make YXX an ideal location for companies looking for a Canadian site to launch or expand their business.

## TECHNOLOGY

British Columbia has a strong reputation in the realm of technology innovation and offers a range of investment opportunities. Home to leading-edge companies in a thriving technology and media sector, the Province boasts \$29 billion in domestic revenues and \$6 billion in exports of goods and services.

Through an \$80 million investment from Telus, Abbotsford has an extensive fibre optic network, wireless services, international roaming and advanced mobile networks which create a high-performing information service at competitive rates, reaching 90% of our homes and businesses. This technology makes us an attractive destination for technology-based businesses.

Tech and data centres see a competitive edge in Abbotsford due to our high capacity fibre optic network. Optic Zoo (now Zayo) have built a comprehensive fibre optic route, with connection points at City Hall and other key locales. The availability of a dark fibre optic connection is just one of Abbotsford's advantages.

We also have the largest concentration of marketing firms in BC, outside of Vancouver, so you're well connected with support agencies.

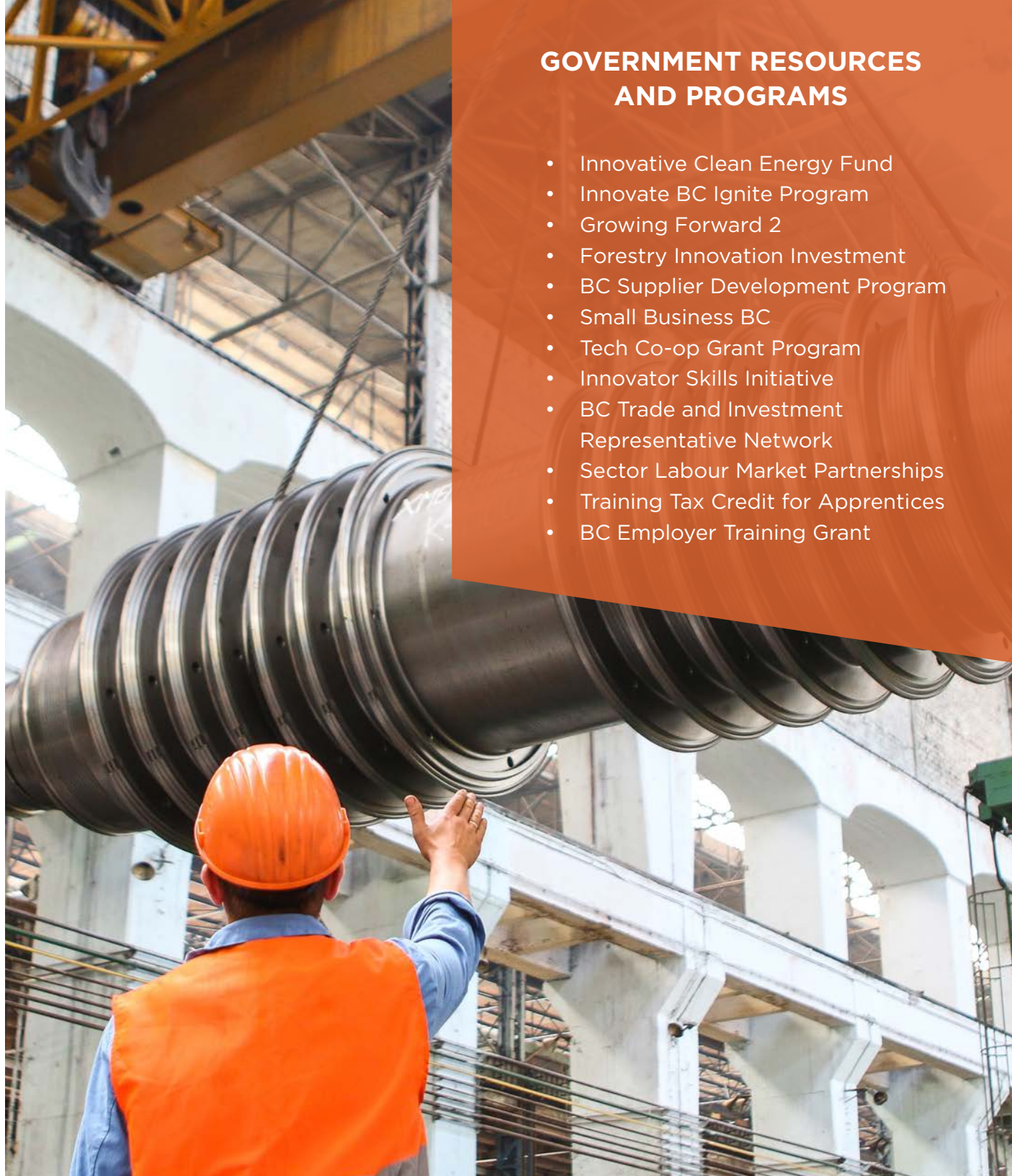
## MANUFACTURING

Manufacturing is a vibrant and vital component of the British Columbia economy. Boasting the largest economic footprint, supporting 12,000 companies and 400,000 jobs, 77% of this sector is comprised of small or medium-sized firms. In 2018, manufactured goods accounted for 61% of BC's total goods exported internationally. Every 100 direct jobs in manufacturing supports 80 additional jobs across multiple sectors in the provincial economy.

Abbotsford is home to a diverse mix of manufacturing operations. With ready access to the region's natural resources, agri-food processing offers many strategic opportunities, but we are also home to innovators in clean tech, life sciences and machinery production areas which are not as reliant on proximity to local resource supply.

The Conference Board of Canada reports that Abbotsford-Mission's real GDP growth is expected to improve from 1.9 percent last year to 2.5 percent this year. Our goods-producing sector will lead the way over the next two years, thanks to growing business opportunities, a lower Canadian dollar and a solid United States economy.

Manufacturing is expected to remain healthy, especially in the wood products industry.

## Quality of Life.

Abbotsford is a city on the move – a growing, dynamic and diverse community recognized by the Intelligent Communities Forum in 2018 as one of the Top 7 intelligent communities in the world. This designation, based on six indicators – **innovation, knowledgeable workforce, sustainability, broadband, digital equality** and **advocacy** – reflects the community-wide collaboration of government, business and the public to embrace change and evolve together.

There are many reasons why Abbotsford strikes a chord with a growing population.

### CLIMATE

While Canada is recognized as a northern country, often best known for its winter weather and pastimes, Abbotsford, nestled in the Fraser Valley near the Pacific Coast, offers a moderate climate that defies the national stereotype.

With average highs in the summer of 24 degrees Celsius and average lows in the winter often above the freezing mark, Abbotsford sees an average of twelve snow days per year – much less than many areas of the country.

### RECREATION & CULTURE

Abbotsford is home to 192 parks which cover more than 841.5 hectares of parkland and feature 276 kilometres of trails suitable for walking, running or cycling. It is estimated that 84% of residents live within 500 metres of a park.

We are home to a number of signature events each year, including the Abbotsford International Airshow which attracts more than 100,000 spectators for their three-day festival. The event has been recognized by USA Today

as one of the ten best airshows around the world. Other events include the long-running Abbotsford Agri-Fair, the Abbotsford Tulip Festival, Berry Festival, and the traditional Canada Day celebrations, which highlight a schedule which sees more than 150 outdoor events hosted each year. These, combined with the sporting events, trade shows and concerts held at the Abbotsford Centre and Tradex respectively, signal an active social calendar which cater to a wide range of interests.

### DIVERSITY

Abbotsford is one of the country's most culturally diverse communities with more than 50 languages spoken by our residents. 30% of our population is South Asian, which contributes to a strong Indo-Canadian business community in all sectors. The Abbotsford Indo-Canadian Business Association has been active for more than 30 years, supporting new entrepreneurs as well as existing merchants to nurture and grow their businesses.

One great example is BC's Punjabi Patrika newspaper, established as the first Punjabi-English newspaper in North America, which holds distinction as one of less than 100 truly bilingual newspapers in the world. The publishers have built an award-winning publication with a home base here in Abbotsford.



## HEALTHCARE

The Abbotsford Regional Hospital and Cancer Centre is the first new hospital built in the Province of British Columbia in 30 years and is the first facility of its kind in Canada to integrate a cancer care centre as part of its design. Opened in 2008, this 645,000 square foot facility features 300 acute care beds, nine operating rooms, psychiatric care, pediatrics, maternity, inpatient isolation rooms, a radiation cancer treatment centre and more. This facility will be soon expanding its ER facilities to continue to adapt to our growing population.

## SCHOOLS

Located in the heart of the Fraser Valley, the Abbotsford School District has **46 schools** that are attended by over **19,200 full and part-time students** at **30 elementary schools, 8 middle schools, 1 combined middle-secondary school, and 7 secondary schools.**

As one of the largest employers in the city, the School District employs more than **2,200 full and part-time teaching and support staff** who are committed to student success.

## GIS MICROSITE TOOL

From creating ground-breaking tools for business and collecting current data on what businesses need to succeed and thrive, the City of Abbotsford is designing opportunities for investment and growth. We have continued to enhance our Geographic Information System (GIS) microsite to include cutting edge tools to help businesses obtain key information.
