### **Zoning Bylaw Amendment** (Proposed)

- Allow 'Cannabis Store' use on 10 lots
- Set a 4-store limit

#### **Development Application Procedures Bylaw** (Proposed Amendment)

- Add new application type for cannabis stores
- Establish consultation process for each application:
  - Agency referrals
  - Newspaper ads
  - Mail-out
  - Council Hearing

#### **Development Application and Service Fee Bylaw** (Proposed Amendment)

- Set an application fee for cannabis stores (\$7,500)
- Set application fees for amendments:
  - Transfer store to a different location (\$7,500)
  - All other amendments (\$1,200)




