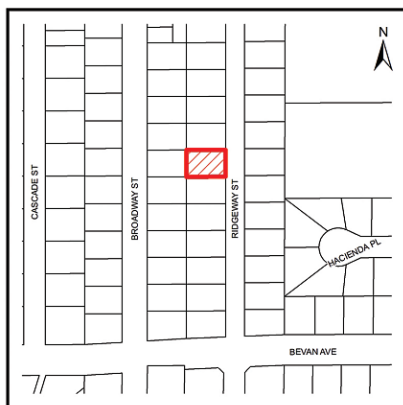

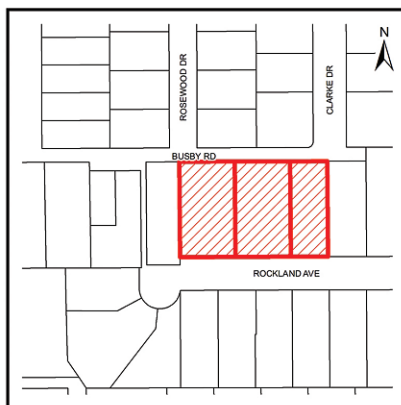

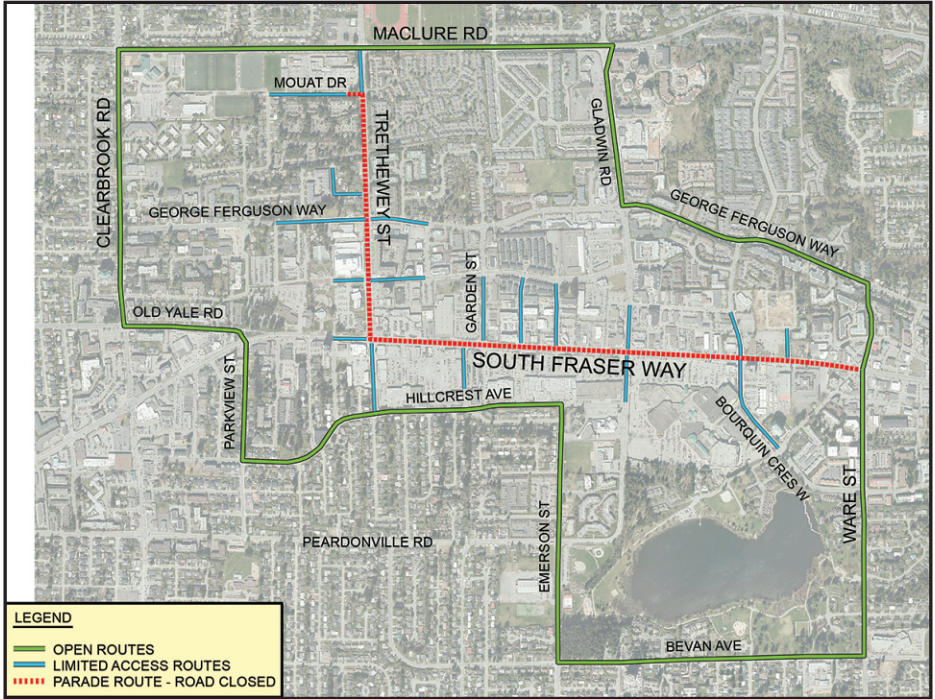

OPTIONS FOR PAYING PROPERTY TAXES

HOW TO PAY

ONLINE IS EASIEST!

Set-up Abbotsford Property Tax as a bill payee through your online banking system and pay as you would any utility or telephone bill.

PAYING BY CHEQUE

Canada Post postmarks are not accepted as the date of payment so please allow for delivery time for your mailed cheque to arrive. City Hall also has drop boxes which are emptied every day. **Cheques only, please!**

PAYING BY CREDIT CARD

Credit cards are only accepted for online tax and utility payments and are not accepted in person at City Hall. To pay online visit abbotsford.ca/creditcard. A 1.75% service fee will apply.

If you need assistance or have questions about taxes, please call 604-864-5522 between 8:30 am and 4:30 pm Monday - Friday or email cash@abbotsford.ca, or visit abbotsford.ca/propertytaxes.

WHERE TO PAY

PAY ONLINE

Residents can easily pay property taxes online at any time through a financial institution. Residents now apply for Home Owner Grants **directly** through the Province of BC. For more information visit gov.bc.ca/homeownergrant.

DROP OFF OR MAIL TO CITY HALL

Cheques for taxes can be mailed or dropped off at a City Hall dropbox. There are 2 dropboxes, one at each entrance. **Please DO NOT include cash.** These boxes are emptied daily.

IN PERSON AT CITY HALL

Residents can pay in person at City Hall. Check in with staff at the tent outside of City Hall. We anticipate there will be a longer waiting period to pay in person. You can drop off your taxes in the drop box, safely and securely without waiting.

GRANTS & PROGRAMS

HOMEOWNER GRANTS

The home owner grant application process has **changed!** Residents in municipalities no longer apply for the home owner grant through their municipal office. Everyone now applies directly to the province using a new online system that's easy to use and will process applications faster. For more information visit gov.bc.ca/homeownergrant.

NOTE that financial institutions do not accept home owner grants.

TAX DEFERMENT PROGRAM

The Province of BC has a tax deferment program. Residential property owners can apply for property tax deferment on their principal residence online, quickly and easily. Owners can also choose to auto renew their application. For more information visit gov.bc.ca/propertytaxdeferment.

NOTE that these services must be applied for through the Province of BC website and not at the City.
