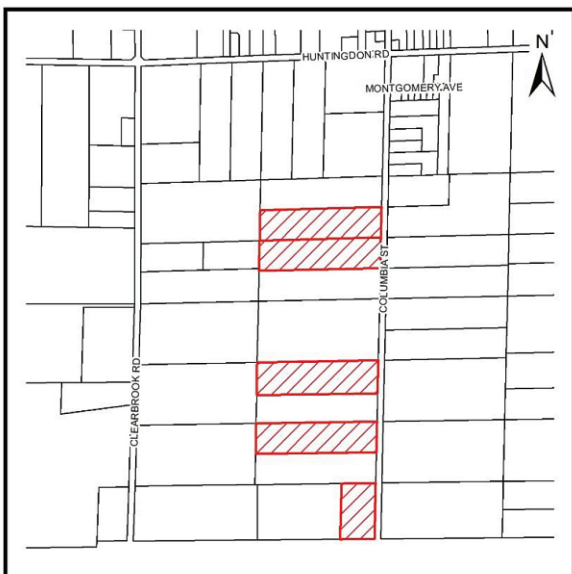


NOTICE OF PUBLIC INFORMATION MEETING AND ONLINE ENGAGEMENT PORTAL

Open house and online consultation for proposed amendment to Official Community Plan Bylaw, 2016 for properties located at 53, 169, 267, 465 and 547 Columbia Street



The City of Abbotsford will hold an open house and an online engagement consultation to consult with the public on a proposal to amend the City's Official Community Plan (OCP). The OCP amendment proposes to amend the Soil Removal Eligibility Area, Map 15 of the OCP, by including the five additional subject properties in order to expand their existing gravel extraction operation.

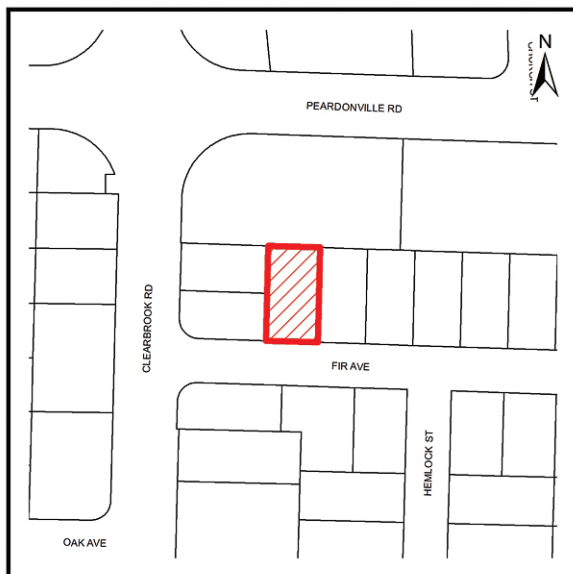

Open house and online consultation for proposed amendment to Official Community Plan Bylaw, 2016 for the property located at 32027 Fir Avenue



The City of Abbotsford will hold an open house and an online engagement consultation to consult with the public on a proposal to amend the City's Official Community Plan (OCP). The OCP amendment proposes to change the land use designation of the subject property from Urban 3-Infill to Secondary Commercial. This amendment is necessary in conjunction with the applicant's proposal to rezone the subject land, and with two additional properties to the west, to develop a healthcare office building.
