- The Nominee has made a positive impact on the lives of people in the City of Abbotsford.
- The Nominee is currently living.
- The Nominee is not an elected federal, provincial or municipal representative.
- The Nominee is not the same person as the Nominator.
- The nomination is not for a group or organization.
- The nomination is not for an act of bravery.

All materials submitted in the Nomination Package become the property of the City of Abbotsford and will not be returned to the Nominator(s) or Nominee.

Order of Abbotsford Nomination Package Information

NOMINATION FORM

Please fill out the Nomination Form (complete with all requested information).

Note that the submission deadline is **May 15, 2023**.

CRITERIA

The criteria for the Order of Abbotsford are as follows:

- Awards are given in recognition of an individual's service to the community or achievements;
- Order of Abbotsford nominees must be living residents or former residents of the City whose exceptional contribution to the community or personal achievement has benefited the City of Abbotsford; and
- Currently elected officials are excluded from nomination while in office.

In order to be considered for the Order of Abbotsford, each nominee must:

- Be an outstanding individual who has been involved in community service and has demonstrated a sustained commitment to the betterment of the residents of Abbotsford.
- Be perceived as a community leader.
- Have influenced community issues, other than through their professional career.
- Demonstrate how the quality of life in the community has been enhanced through their civic involvement.
- Have demonstrated excellence, creativity and initiative in their community service.

NOMINATION QUESTIONS PACKAGE

In the fillable pdf pages provided, please answer each question to describe the nominee's significant contributions and highlights for nomination. You may include copies of photographs, news clippings, and/or Curriculum Vitae in addition to your answers in the submitted package.

LETTERS OF SUPPORT

Each of the two (2) supporting nominators must submit a one-page letter in direct support of the nomination. Letters should be addressed to the City Clerk and include the writer's name and signature.

SELECTION PROCESS

The selection process is based on the information specified above and submitted in the nomination package. If any of the requirements and criteria are not submitted with the nomination package, the nominee will be automatically disqualified.

FORMAT REQUIREMENTS FOR NOMINATION PACKAGES

The format requirements for nomination packages:

1. All answers must be completed in the Nomination Package pages (fillable pdf). All answers must be typed. Hand-written applications will NOT be accepted or considered.
2. All newspaper clippings, photographs, etc, should be photocopied or scanned for inclusion in the electronic package.
