barriers they face, what they require and what is the most effective way to work with women that are trafficked.

- Co-chair, Rod Santiago informed the committee that Archway Community Services is working on a flood resilience center located in the Sumas flats for people that have been negatively impacted by the floods to assist with recovery.
- The committee discussed the Lonzo park and ride encampment and how dangerous, unstable and unsafe the area has become.
 - Abbotsford Police have been very great in monitoring and handling various situations.
 - The committee was informed that things are in motion, are ongoing and certain steps have to take place with the hope that it all happens by the end of the week.
 - The Provincial Government will not break up the homelessness camp unless there is housing in place for the people that are moved.

The committee members were reminded that the next meeting date for the CAB is June 1, 2022.
