

Notice of 2024 Permissive Tax Exemptions

Pursuant to Section 224 of the *Community Charter*, the Council of the City of Abbotsford will consider Bylaw No. 3471-2023, Permissive Tax Exemption (2024) Bylaw for adoption at the Council Meeting on Monday, October 30, 2023 directly following the Public Hearing commencing at 6:00 PM, in the Matsqui Centennial Auditorium, City Hall at 32315 South Fraser Way, Abbotsford, BC.

Bylaw No. 3471-2023, Permissive Tax Exemption (2024) Bylaw, exempts from taxation for the year 2024 the following land and/or improvements. Exemptions for 2025 and 2026 are dependent on eligible organizations submitting a completed application by June 30 of each year, as well as the annual budget set by Council.






