

## Organizations Required to Submit Comprehensive Tax Exemption Applications

Pursuant to <u>Council Policy C008-05</u>, <u>Permissive Tax Exemption</u>, the below guidance is offered to organizations seeking permissive tax exemptions:

"[Applicants] approved for an Exemption, based on completion of a Comprehensive Exemption Application, will be exempt for one (1) year. To be considered for future years, a Renewal Application must be submitted on or before June 30th of the preceding year for each year remaining in the application cycle. Following completion of an Application Cycle, the Applicant will again be required to submit a Comprehensive Exemption Application."

The *Application Cycle* for Not-for-Profit Organizations, Community Care Facilities and Athletic or Service Clubs is four (4) years.
