

NOTICE OF 2026 TAX SALE

Pursuant to Section 645 of the Local Government Act, the following properties will be offered for sale by public auction at 10:00 am, Monday, September 28, 2026, in the Council Chambers of the Matsqui Centennial Auditorium, 32315 South Fraser Way, Abbotsford, B.C., unless delinquent taxes, plus interest thereon, are paid by cash, certified cheque, money order or bank draft prior to 4:30 pm, Friday, September 25, 2026.

The lowest amount for which a property may be sold is the upset price, which is equal to the total of delinquent taxes, arrears taxes, current taxes, penalties, interest, and 5% thereon, plus applicable fees under the Land Title Act.

Those wishing to bid on properties must register and obtain a bidding card between 9:00 am and 9:50 am on Monday, September 28, 2026, at the Council Chambers of the Matsqui Centennial Auditorium.

All bidders must:

- Provide a bank draft payable to the City of Abbotsford for the maximum amount you intend to spend at the auction to receive a bidding paddle. Cash, debit cards, credit card, personal/business cheques will NOT be accepted as form of payment.
- Provide government-issued photo identification, occupation, current contact information, social insurance number (individuals) or business number (corporations).
- If a bidder is successful in purchasing a property or properties, the successful bid price(s) will be deducted from the bank draft provided at registration. Any unused balance will be refunded within one week.
- The successful bidder must pay the full purchase price immediately following the auction using the bank draft provided at registration.
- If a bidder is unsuccessful at the auction, the bank draft will be returned immediately following the auction.

Tax Sale will begin promptly at 10:00 am.

Properties sold at the tax sale may be redeemed by the owner up to September 28, 2027, in which case, the tax sale purchase price, plus interest, will be returned to the purchaser. For more information, contact the Tax Department at 604-864-5522 between 8:30 am and 4:30 pm, Monday to Friday.

The City of Abbotsford makes no representation, express or implied, as to the condition or quality of the properties being sold. Prospective purchasers are urged to be familiar with the properties and make all necessary inquiries to municipal or other government departments, and in the case of strata lots to the strata corporation, to determine the existence of any bylaws, restrictions, charges or other conditions which may affect the value or suitability of the property.

The purchase of a tax sale property is subject to tax under the Property Transfer Tax Act on the fair market value of the property.

NOTICE OF ADVANCE VOTING

Advance Voting will be available to qualified electors of the City of Abbotsford on October 7, 10 and 11, from 8:00 a.m. – 8:00 p.m., at the following locations:

Drive Through	Abbotsford Exhibition Park - Gate 2	32470 Haida Drive

Drive Through voting at Abbotsford Exhibition Park - Gate 2, is available to all voters. **All curbside voting will take place at this location.** Curbside Voting is not available at the Old Abbotsford Courthouse location.

ELECTOR REGISTRATION

If you are not on the list of electors, you may register at the time of voting by completing the required application form available at the voting location and making a declaration that you meet the requirements to be registered as set out below. Qualified electors must also produce the required identification.

Resident Electors

In order to qualify, resident electors must satisfy the following:

- 18 years of age or older on general voting day for the election or assent voting; and
- a Canadian citizen; and
- a resident of British Columbia for at least six months immediately before the day of registration; and
- a resident of the City of Abbotsford; and
- not disqualified under the *Local Government Act*, or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

To register, resident electors must produce at least two (2) documents that provide evidence of their identity and place of residence, at least one (1) of which must contain their signature.

Non-Resident Property Electors

In order to qualify, non-resident property electors must satisfy the following:

- 18 years of age or older on general voting day for the election or assent voting; and
- a Canadian citizen; and
- a resident of British Columbia for at least six months immediately before the day of registration; and
- a registered owner of real property in the City of Abbotsford for at least 30 days immediately before the day of registration; and
- the only persons who are registered owners of the property, either as joint tenants or tenants in common, are individuals who are not holding the property in trust for a corporation or another trust; and
- not entitled to register as a resident elector; and
- not disqualified under the *Local Government Act*, or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

To register, non-resident property electors must produce: at least two (2) documents that provide evidence of their identity, at least one (1) of which must contain their signature; proof that they are entitled to register in relation to the property; and, if there is more than one owner of the property, written consent from the other property owners, using the form available at www.abbotsford.ca/elections/voter-information.

Types of Documents that will be Accepted as Identification

The following classes of documents will be accepted as evidence for the purposes of section 72 or section 73 of the *Local Government Act*:

- (a) a British Columbia Driver's Licence,
- (b) a BC identification card within the meaning of the Identification Card Regulation,
 - (b.1) a photo BC services card within the meaning of the Identification Card Regulation,
 - (b.2) a non-photo BC services card within the meaning of the Identification Card Regulation,
 - (b.3) a document, issued by the government of Canada, that certifies that the applicant is registered as an Indian under the *Indian Act* (Canada),
 - (b.4) a citizenship or membership card issued by a first nation,
 - (b.5) a citizenship card issued by Métis Nation British Columbia,
- (c) an Owner's Certificate of Insurance and Vehicle Licence issued by the Insurance Corporation of British Columbia,
- (d) a British Columbia CareCard or British Columbia Gold CareCard,
- (e) a Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8,
- (f) a Social Insurance Number card or confirmation of Social Insurance Number letter issued by the government of Canada,
- (g) a Citizenship Card issued by Citizenship and Immigration Canada,
- (h) a real property tax notice issued under section 237 of the *Community Charter* or section 21 of the *Taxation (Rural Area) Act*,
- (i) a credit card or debit card issued by a savings institution as defined in section 29 of the *Interpretation Act*, or
- (j) a utility bill issued for the supply of electricity, natural gas, water, telephone services or coaxial cable services by
 - (i) a public utility as defined in section 1 of the *Utilities Commission Act*,
 - (ii) a gas utility as defined in section 1 of the *Gas Utility Act*,
 - (iii) a water utility as defined in section 1 of the *Water Utility Act*,
 - (iv) the British Columbia Hydro and Power Authority, or
 - (v) a corporation licensed by the Canadian Radio-television and Telecommunications Commission for the purposes of that supply.

The above listed identification documents MUST be accepted by election officials. Sections 72(3) and 73(3) of the *Local Government Act* allow other documents to be accepted at the discretion of the election official (e.g. a valid, current passport).

NOTICE OF PERMISSIVE TAX EXEMPTIONS
FOR THE 2027 TAXATION YEAR

Pursuant to Section 224 of the Community Charter, Bylaw No. 3766-2026, “Permissive Tax Exemption (2027) Bylaw, 2026” will be introduced at the September 22, 2026, Council Meeting. If Council grants first three readings on September 22, 2026, then this bylaw will be considered for adoption at the October 6, 2026, Council Meeting. This meeting is scheduled for 3:00 p.m. and will be held in the Matsqui Centennial Auditorium, located at 32315 South Fraser Way, Abbotsford, BC.

Bylaw No. 3766-2026, Permissive Tax Exemption (2027) Bylaw, 2026 exempts from taxation for the year 2027 the following land and/or improvements. Exemptions for 2028 and 2029 are dependent on eligible organizations submitting a completed application by June 30 of each year, as well as the annual budget set by Council.
