

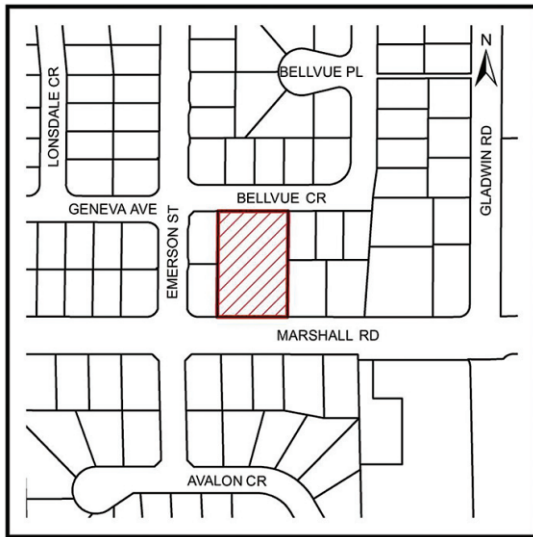
Notice of Public Hearing

to consider an amendment to Abbotsford Zoning Bylaw, 2014

Abbotsford Council will hold a Public Hearing at 7:00 pm on February 4, 2019, in the Matsqui Centennial Auditorium, 32315 South Fraser Way, Abbotsford, B.C., under the provisions of the *Local Government Act* to consider the following bylaw. At the Public Hearing, all persons who believe their interest in property is affected by the proposed bylaw will be afforded a reasonable opportunity to be heard or to present written submissions respecting matters contained in the bylaw that is the subject of the hearing.

ABBOTSFORD ZONING AMENDMENT BYLAW BYLAW NO. 2889-2018



SUBJECT LAND: 32731 Marshall Road
CURRENT ZONING Urban Residential Zone (RS3)
PROPOSED ZONING Comprehensive Development Seventy Five (N75)
PURPOSE: If Bylaw No. 2889-2018 is adopted, the applicant proposes to develop a seven lot subdivision.
