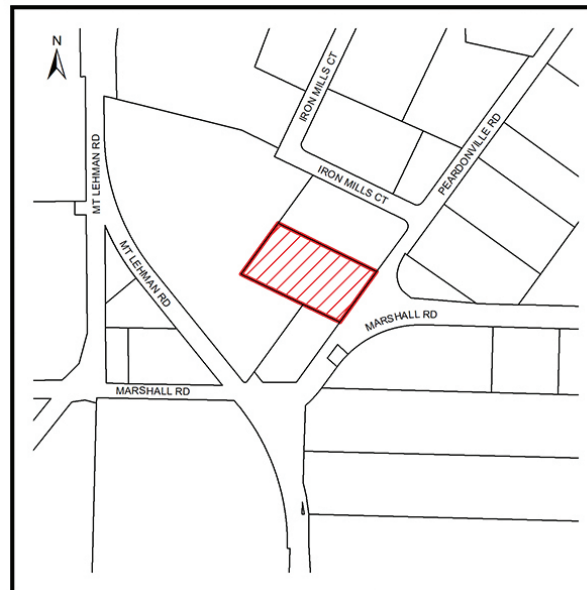

ABBOTSFORD ZONING AMENDMENT BYLAW BYLAW NO. 2993-2019



SUBJECT LAND: 3107 Lefevre Road
CURRENT ZONING: Urban Estate Residential Zone (RS1)
PROPOSED ZONING: Residential Zone (RS5)
PURPOSE: If Bylaw No. 2993-2019 is adopted, the applicant proposes to develop a two lot subdivision.

ABBOTSFORD ZONING AMENDMENT BYLAW BYLAW NO. 2947-2019



SUBJECT LAND: 2059 Peardonville Road
CURRENT ZONING: Agricultural One Zone (A1)
PROPOSED ZONING: General Industrial Zone (I2)
PURPOSE: If Bylaw No. 2947-2019 is adopted, the applicant proposes to construct a warehouse facility for industrial gas storage and filling.
