

# Inter-municipal Ride Hailing Business Licence Bylaw, 2020, Bylaw No. 3024-2020

The intent of this bylaw is to provide for a regional business licence for ride-hailing businesses which allows them to operate across jurisdictional boundaries in the Lower Mainland, Whistler and Fraser Valley regions.

#### Business Licence Amendment Bylaw, 2020, Bylaw No. 3021-2020

The intent of this bylaw is to remove ground transportation fees from the Abbotsford Airport Fee Bylaw, 2018; and adding ride-hailing and other vehicle for hire provisions, and repealing the current Vehicle for Hire Bylaw, 2017.
