



Notice of Construction/Road Closure

The City of Abbotsford will be replacing three culverts on Pepin Brook, under Huntingdon Road, near 28265 and 28215 Huntingdon Road. This project aligns with the City's strategic goal of improving public safety. Luxton Construction Inc. is the contractor completing the works.

Huntingdon Road, between Lefeuvre Road and Bradner Road, will be fully closed to through traffic on the following dates:

- 3:00 pm, August 15, 2020 to 7:00 am, August 17, 3:00 pm, August 22, 2020 to 7:00 am, August 24, 3:00 pm, August 29, 2020 to 7:00 am, August 31, 2020 2020

There will be single-lane alternating traffic on Huntingdon Road, between Lefeuvre Road and Bradner Road, between August 10 and September 15, 2020 from 7:00 am to 7:00 pm, except during the

dates and times noted above. Detour routes will be in place during the road closures. Access to private properties will remain open at all times. A detour map is shown below.



Pursuant to section 59(2) of the Community Charter, public notice is required to consider the following: BYLAW ENFORCEMENT AMENDMENT BYLAW, 2020. If Bylaw No. 3063-2020 is adopted, it repeals section 12.2 of the Business Licence Bylaw, 2006 and section 4.4 [offence and penalties] of the Fireworks Bylaw, 2005 that creates offences and penalties for contravention, which are obsolete in light of sections 3 [general offence] and 6 [general penalty] of the Bylaw Enforcement Bylaw, 2020.
